I am requesting funding for the GCRTA Light Rail Track Reconstruction Program project in the Fiscal Year 2025. The entity to receive funding for this project is the Greater Cleveland Regional Transit Authority (GCRTA), located at 1240 West Sixth Street Cleveland, OH 44113. The funding would be used for the Light Rail Track Reconstruction Program which will reconstruct approximately 10 miles of the light rail track constructed in 1980 from Kinsman Road east through Shaker Square and to the eastern ends of the Blue and Green Lines. The project is an appropriate use of taxpayer funds because completion of this project will provide customers with safer, faster, smoother, and more reliable rail service in this area.

The project has a Federal nexus because the funding provided is for a transit infrastructure project eligible under chapter 53 of title 49 of the United States Code.
